The Estero Council of Community Leaders, invites you to submit your application to exhibit and sell in the Arts & Crafts area of the "Arts Estero 2009" celebration on Saturday, March 28, 2009 from 11 a.m. to 5 p.m.

1. No commercial dealers, agents or dealers, kits, castings from commercial molds or mass-produced items. Fine art reproductions may be sold only if signed and numbered. Mechanically reproduced work may be displayed if clearly marked "Reproductions."
2. The selection of artists for the show by the Selection Committee is final.
4. Entrance donation of \$35 with application, check or money order must accompany each application. Checks will be deposited upon receipt. Donation will not be refunded if unable to attend.
5. Each exhibitor must comply with all pertinent State of Florida sales tax regulations. Each artist is responsible for collecting and paying to Florida Department of Revenue, Florida Sales Tax of 6%.
6. No refunds will be made for cancellation by exhibitor.
7. No refunds shall be made for inclement weather or other acts of God, local authority or weather related cancellations which the sponsor has no control. Risk and/or loss from such an event shall be borne by the exhibitor.
8. No subletting or selling of space to anyone is permitted. Only the type of arts/crafts selected for entry may be exhibited and sold.
9. Each exhibitor must display a sign with his/her name, craft and home city of a minimum of 8 1/2" x 11".
10. An exhibitor I.D. badge will be issued and must be worn at all times by the exhibitor.
11. Check in time is between 7:00 am and 10:30 am Saturday, March 28, 2009. Exhibitors not there by 10:30 am, will forfeit their fee and their space may be reassigned.
12. Displays must be set up by 11:00 am. Saturday. You may not dismantle your display until after the intermission by the Gulf Coast Symphony Orchestra. Display must be manned at all times by the exhibitor.
13. Exhibitors must furnish their own displays. There are no more tables and chairs to be provided by us. Displays must be strong enough to withstand winds and crowds. Exhibitors are responsible for damages

- caused by these displays. Tents if you have them are encouraged. However there is not staking them. They have to be weighted down.
14. **Exhibit space is approximately 10 feet around the back side of the green space.**
 15. Artist is responsible for keeping his assigned area clean during the show and area cleared after the show.
 16. **Application deadline is March 15, 2009 for being included in program and other print material.** Applications will be accepted up to three days before the event.
 17. The committee reserves the right to expel without refund any exhibitor. The committee reserves the right to reject any work it considers unsuitable. Exhibitors must follow suggestions made by Arts Estero 2009 Committee or appointed representatives during the day of March 28, 2009.
 18. 'Arts Estero 2009' committee reserves the right to make final interpretation of all rules.
